This is an urgent reminder regarding your Annual Membership Subscription.

### Action Required: Settle Outstanding Fees by December 31, 2025!

Default Deadline: The final deadline for the current year's subscription was June 30<sup>th</sup>, 2025, but the council has approved December 31, 2025. Members who fail to remit their full annual subscription fee by this date are considered defaulters.

Penalty Imposition: A penalty fee will be levied on all outstanding balances immediately following the default deadline.

Standard Payment on or before December 31st, 2025.

### Consequence of Prolonged Default

#### \*Revalidation of Membership Status Required\*

Any member who remains in default of their annual subscription for three (3) cumulative years will be required to undergo a formal revalidation process of their membership status with the Institute and a fee is attached.

Note, this is in addition to paying all outstanding subscriptions and accrued penalties.

#### Timely payment is crucial for:

Maintaining Active Status: Ensures your membership remains Active and your name is retained on the official Register of the Institute.

Access to Benefits: Guarantees uninterrupted access to all NIMN events, continuous professional development (CPD) programs, networking opportunities, and voting rights.
